CPS finance chief outlines plan to address projected deficit

(continued from page 1) allow for stringent year-end planning and will determine the extent to which they will need to tap into revolving accounts and/or the Special Education Reserve Fund to offset any

remaining deficit. Initial projections after the end of the first quarter estimate using \$600,000 in revolving account funds and, if needed, up to \$1 million of the \$1.5 million in the Special Education Reserve Fund.

School Committee member Maureen Moran expressed her concern about tapping into the Special Education Reserve Fund, which she said should only be used for extraordinary and unforeseen special education costs.

School officials are currently awaiting the FY26 budget parameters from the Finance Committee and should have those figures by the next School Committee meeting on February 27. The committee will then have a few weeks to consider and pass a new operating budget. Over the last five years, the FinCom has approved annual budget increases of between 3 and 7 percent.

In other news:

* Committee members formally approved the district calendar for the 2025-26 school year, which will begin on Tuesday, September 2 — the day after Labor Day — for students in grades 1-12. The first day for PreK and kindergarten students will be Thursday, September 4. The calendar also includes a professional

development day for staff on Friday, January 2, with school resuming for students on January 5. Early release days will continue to be held on selected Wednesdays. A copy of the approved calendar can be found on the CPS website under the February 6 "Meeting Materials" link at cantonma.org/school-committee/ school-committee-minutes-agendas

* The state Department of Elementary and Secondary Education (DESE) released its district report cards last week, and principals were expected to share the report cards for each school on Monday, February 10. The report card includes multiple measures of the district's performance, and according to School Superintendent Derek Folan, it is more than just a summary of MCAS scores. "It represents a new way of looking at our performance by providing information on student achievement, teacher qualifications, student learning opportunities, and more," said Folan.

* GMS Principal Jonathan Mulhern presented the school's program of studies for 2025-26 and said there are only two changes with regard to course offerings. For incoming eighth graders who are new to the school and have not taken French or Spanish in grade 7, there will be a Survey Cultures course offered to help them become acquainted with the languages and cultures of the French and Spanish-speaking worlds. The second course addition is a Soundtrack-Music Production class

that will be offered to eighth graders. Mulhern said more significant course changes could occur at this time next year as they prepare for the addition of grade 5 to the middle school beginning in 2028.

* CHS student Sonia Le was selected to participate on string bass in the prestigious All-State Orchestra sponsored by the Mass. Music Educators Association. Le is slated to perform with the orchestra at Symphony Hall on Saturday, March 29.

* GMS eighth grader Jacob Sallette entered an original composition and was chosen to participate in the 2025 Contemporary Creators Festival on Thursday, March 27, where he will get direct feedback from a clinician on his composition.

* February is Black History Month and Folan said this year's national theme is "African Americans and Labor." On Friday, February 14, the Galvin Middle School will hold a special Black History Month event featuring poster board presentations of Black inventors, student singers, and step choreography featuring over 60 student participants. This event will take place in the school cafeteria from 9 to 10:30 a.m. Canton's Diversity, Equity and Inclusion Committee is also planning a Black History Month celebration on February 26, from 6-8 p.m. at Topgolf.

* The School Committee will next meet on Thursday, February 27, at 6 p.m. in the Canton High School Distance Learning Lab.

Students gain hands-on experience for future STEM careers through **Project Lead the Way**

What is it really like to be an engineer? How can an interest in coding lead to a career as a computer scientist? A nationwide program called "Project Lead the Way" (PLTW) is helping Canton students answer these questions before heading to college or trade school.

"This program builds skills for students wanting to go into any of the STEM or STEAM careers," said CHS PreK-12 Instructional Technology Coordinator Kevin Sullivan. "It gives them the building blocks they need to look forward to these careers."

Students in Katie Healey's PLTW engineering class were recently tasked with creating a charm that would be sent to a fictional company's best customers. Working in pairs, they acted first as the designer, and then as the client, sharing personal information about their passions and hobbies. The students used computer aided design (CAD) to create their design. They then used a 3-D printer to produce the charm that can be hung from a backpack.

"I love that these projects are very real world," said CHS Science Department and PLTW Coordinator Erica Fitzgerald. "They put students are given a client and requirements

and restraints, and they need to use lab-focused skills like collaboration, coordination and communication. The kids see purpose in everything they're learning, and they definitely see the career potential associated with these skills."

"I really like how we do activities and projects that have to do with engineering and it's not just working on paper," said CHS senior Alyssa Nordgren. "We actually do things that engineers would do. I want to Environmental Sustainability, be an engineer, so it is giving me a look into that career."

Many of the students in Jackie Morrissey's PLTW computer science class are thinking about careers in

Senior Max Mateo is planning a career in robotics. "I've been involved in robotics for a while, and while the mechanical end is more of my focus, I also have an interest in programming and the software end of robotics, so I wanted to learn more about that area."

"It's great that we offer them a foundation to get into this career path," said Morrissey. "It's also a great class to work on problem solving. It can be rigorous at times, so dealing with productive struggle and figuring out how to solve problems different ways is something we

Many colleges offer students

college credits for PLTW classes they took in high school — saving them both time and money. These schools include Worcester Polytechnic Institute, Wentworth Institute of Technology, UMass Boston and Mass. Bay Community College.

Canton also offers several PLTW classes at the middle school level. Administrators are hoping to add several new classes for high school students next year, including additional Engineering and Computer Science offerings, and a capstone project where students would be required to design, market and produce a project.

"This program is valued at the collegiate level, so it puts our kids in a really good spot from high quality learning experiences that are proven to translate," said Principal Jeffrey Sperling. "We are fortunate to have teachers who are willing to learn and be part of this program. Hopefully we can continue to grow this and give our students the experiences they deserve."

Students can begin signing up for classes on March 7. In addition, students and parents/guardians can learn more about PLTW programs during an informational session on February 27 at 4 p.m. in the CHS also be shared.
